# DECLARATIONS OF INTERESTS CONFLICT OF INTEREST AND PECUNIARY INTEREST

# 7.2.3 NOTICE OF MOTION NO. 6 - GENETICALLY MODIFIED ORGANISMS AND POTENTIAL IMPACTS ON THREATENED FLORA

### **Document Information**

### **CR DAVID JONES**

### **Genetically Modified Organisms and Potential Impacts on Threatened Flora**

That the Greater Bendigo City Council request:

- 1. The Federal Minister for the Environment to investigate the impact of Genetically Modified Organisms under Section 69 of the Federal Environment Protection and Biodiversity Conservation Act 1999.
- 2. The State Government to declare the City of Greater Bendigo a GE Free Zone, as is possible under Section 21 of the Victorian Gene Technology Act, on marketing grounds.

### Rationale:

Such a move will allow the City to continue its role as a leader in the GE debate; and

to market itself as a "clean, green, GE free" food producer.

All farmers and food producers, including those in organic, biodynamic and conventional farming systems, will be able to market their produce as "GE Free". This will protect their already established markets, whether within or outside the City, or to export markets.

It will prevent the facing of extra costs by farmers and food producers for GE testing, segregation provisions and separate distribution lines, to ensure the integrity of their products and keep GE material from their food lines.

### Background:

The right to declare an area a GE Free Zone has been enshrined in the legislation, both state and federal, and recognised by the federal Gene Technology Ministerial Council as a Policy Principle.

The Commonwealth Gene Technology Act 2000 called for the establishment of the federal Gene Technology Ministerial Council (GTMC), consisting of one government representative from each state. Established in 2001, its purpose is to issue policy principles, policy guidelines and codes of practice to govern the activities of the Gene Technology Regulator and the operation of the national legislative framework for the operation of GMOs.

State representatives of the GTMC stand for at least one year. Victoria's current representative is Daniel Andrews, Minister for Health.

Note: The ability to designate areas as GM or non-GM designated areas is left to the States (under Section 21).

Recognition of Designated Areas Principle - enacted Sept. 2003.

"Any state may designate an area for the purpose of preserving the identity of GE, non-GM crops, or both GM and non-GM crops, for marketing purposes."

Cr Reynard declared an interest in 7.2.3 Notice of Motion No. 6 (Genetically Modified Organisms and Potential Impacts on Threatened Flora) as he is employed by the Department of Primary Industries who are involved in the debate on this issue.
